Dear Chair Khan:

We write in support of our constituents who utilize the franchise business model to open and grow their businesses. The Commission has an opportunity to support these franchise businesses, and we write to ensure any upcoming Commission action will result in meaningful and immediate benefits to franchising, a business model that has proven resilient through the pandemic and continues to make significant contributions to the U.S. economy.

The approximately 800,000 franchised businesses operating in the U.S. support nearly 8.4 million direct jobs, contribute \$825.4 billion of economic output for the national economy, and comprise almost 3 percent of the Gross Domestic Product,¹ with almost half being owned by single-unit small business owners.² Franchising has successfully created a path to entrepreneurship for business owners of all backgrounds and enabled these owners to create wealth in communities across the nation. A greater percentage of franchise businesses are owned by people of color (30.8 percent) than non-franchise businesses (18.8 percent).³ Furthermore, sales in franchised businesses exceed non-franchised businesses across all demographic cuts, including gender and race. For example, Black-owned franchise firms generate an average of 2.2 times as much in sales compared to Black-owned non-franchise businesses.⁴

We are aware that the Commission's Franchise Rule has been under review and that the Commission separately has sought public comment and information related to the franchise relationship. Further, we are aware that numerous submissions to the Commission's Request for Information (RFI) called for improved presale disclosures. We support those comments. Specifically, we agree with members of the franchise community who have suggested the Commission can:

- Provide greater visibility and transparency of key franchise terms and conditions,
- Modernize franchise disclosures, including executive summaries included with Franchise Disclosure Documents (FDDs), and
- Encourage added dialogue through the promotion of independent franchisee associations and franchise advisory councils.
